Director De La Cruz asked to pull Agenda Item 7 for discussion.

There was no public comment on the Consent Agenda.

Upon a motion duly made by Director Gomez, and seconded by Director De La Cruz, the Directors unanimously approved Items 1-6 and 8 from the Consent Agenda.

## **Regarding Item 7:**

Director De La Cruz wanted to know the names of the other bidders and their bid amounts.

Ms. Postigo stated that staff did not usually list all of the proposals and bid amounts. Four proposals were received and reviewed by a panel, who selected Schipper Design as the most qualified consultant.

Director De La Cruz stated that the contract was not awarded based on the lowest bidder; it was awarded based on experience, which raised questions for him. He stated that he could not approve a contract without viewing all of the bids that were submitted.

Director Botelho stated that he was comfortable with approving the contract because the contractor is not only local, but has been used before, and has experience in the field. He mentioned that previously, a contract was awarded to a company from Los Angeles, which may have been the lower bidder; however, their work did not meet expectations.

Director De La Cruz stated that the Board should ensure that they are doing their best to select based on fairness and most cost effective.

Chair Emerson stated that when dealing with a professional services contract, most would agree that the cheapest isn't always the best. He stated that he would support this contract, however, he agreed with Director De La Cruz by stating that in the future, he would like to see a report listing the dollar amounts, and reasons why the contractor is selected.

Upon a motion duly made by Director Botelho, and seconded by Director Gomez, the Directors approved Item 7, with Director De La Cruz voting No: Motion Passes 4/1

Upon a motion duly made by Director De La Cruz, and seconded by Director Botelho, the Directors unanimously adjourned the COG meeting.
