Chair Flores called the meeting to order at 6:34 p.m.

6. Receive Local Transportation Authority FY 2018-19 Second Quarter Budget Report and **Approve** Budget Adjustment/Transfer 18-19-07 – Postigo

Ms. Postigo provided a report on the Local Transportation Authority's FY 2018-19 Second Quarter Budget Report. She noted that a budget adjustment/ transfer was required to increase the Maintenance of Equipment – Oil and Gas line item for \$18,430.

There was no public comment or discussion on the item.

Upon a motion duly made by Director Velazquez, and seconded by Director Gillio, the Directors unanimously approved Item 6. Vote: 4/0 motion passes.

7. Approve Contract between the San Benito County Local Transportation Authority (LTA) and Kimley-Horn and Associates, Inc. for an Amount Not to Exceed \$150,000 for the Preparation of an Analysis of Public Transit Network Expansion Projects for Congestion Relief of the Highway 25 Corridor Study – Valentine

Regina Valentine stated that staff was requesting authorization from the LTA Board to enter into contract with Kimley-Horn and Associates, Inc. to prepare the study. Ms. Valentine noted that during contract negotiations, Kimley-Horn requested additional clauses to be added to the contract as Attachment D, specific terms and conditions that apply to professional engineers. Kimley-Horn requested a broader application of California Civil Code section 2782.8.

Director Richman asked if they would be looking at other things besides rail, such as buses to the San Jose Airport or temporary road modifications.

Ms. Valentine stated that they would look at things that are more specific to public transit, such as bus rapid transit. There are also some pilot programs that have been conducted in Monterey where they have buses on shoulders during certain congestion times.

Deputy County Counsel, Shirley Murphy reviewed the requested changes and advised that the LTA Board not agree to the proposed changes. She went over the reasons why with the Board. She recommended that if the Board agreed to Attachment D, that they do so with the following wording added to their approval: The Board approves the contract with their requested version of Attachment D with the additional language from the Board: reflecting that it is limited to this contract only and in no way imply in any shape or form that this applies to any future contracts or deals with San Benito County, City of Hollister, and the City of San Juan Bautista or the Council of San Benito County Governments.

There was no public comment.

Upon a motion duly made by Director Gillio, and seconded by Director Velazquez, the Directors unanimously approved Item 7 approving the Contract with Kimley-Horn and Associates, Inc. with their requested version of Attachment D, with the additional language from the Board limiting the scope of this Attachment D to this contract only and not to any future contracts with San Benito County, City of Hollister, City of San Juan Bautista, and/or the Council of San Benito Governments. Vote: 4/0 motion passes

Upon a motion duly made by Director Velazquez, and seconded by Director Richman, the Directors unanimously adjourned the LTA meeting at 6:47 p.m. Vote: 4/0 motion passes unanimously.

Subject: Low Carbon Transit Operations Program

Recommendation:

ADOPT Resolution 2019-02 authorizing the execution of the Low Carbon Transit Operations Program (LCTOP) projects "Expansion of Intercounty Services," "Token Transit Agency Fees," and "Free Fixed Route and Intercounty Service Days."

Summary:

The Low Carbon Transit Operations Program (LCTOP) provides funding for transit services that reduce greenhouse gas emissions. For Fiscal Year 2019/20, LTA is proposing to use the funds for additional trips for the County Express Intercounty service, to cover the agency costs of operating the Token Transit mobile ticketing app pilot program, and to offer free Fixed Route trips during the first week of the month and free Intercounty trips during the low-ridership months of December, January and June.

Financial Considerations:

\$107,615 is earmarked for San Benito County LTA from the LCTOP.

Background:

The Low Carbon Transit Operations Program (LCTOP) is one of several programs that are part of the Transit, Affordable Housing, and Sustainable Communities Program established by the California Legislature in 2014 by Senate Bill 862. The LCTOP was created to provide operating and capital assistance for transit agencies to reduce greenhouse gas emissions and improve mobility, with a priority on serving disadvantaged communities. Approved projects in LCTOP will support new or expanded bus or rail services, expand intermodal transit facilities, and may include equipment acquisition, fueling, maintenance and other costs to operate those services or facilities, with each project required to reduce greenhouse gas emissions.

Staff Analysis:

The State requires local agencies adopt an annual resolution in order to be eligible to receive funds for LCTOP Projects. A draft version of the resolution was submitted on the March 28, 2019

deadline as part of the LCTOP allocation request due to Caltrans. The LCTOP project submitted was to:

- Continue the "Intercounty Service Expansion" project from the last cycle, which added trips to the County Express Intercounty service for people traveling between San Benito and Santa Clara Counties;
- Add the project "Token Transit Agency Fees" to cover the operating costs of the Token
 Transit mobile ticketing app pilot program approved by the Board at the December 2017
 meeting, an app which has been popular addition with the passengers, especially those
 riding the Intercounty services; and to
- Add the project "Free Fixed Route and Intercounty Services Days," where LTA will offer free Fixed Route trips during the first week of the month and free Intercounty trips during the low-ridership months of December, January, and June, in an effort to spark a ridership increase systemwide.

WHEREAS, the San Benito County Local Transportation Authority (LTA) is an eligible project sponsor and may receive state funding from the Low Carbon Transit Operations Program (LCTOP) now or sometime in the future for transit projects; and

WHEREAS, the statutes related to state-funded transit projects require a local or regional implementing agency to abide by various regulations; and

WHEREAS, Senate Bill 862 (2014) named the Department of Transportation (Department) as the administrative agency for the LCTOP; and

WHEREAS, the Department has developed guidelines for the purpose of administering and distributing LCTOP funds to eligible project sponsors (local agencies); and

WHEREAS, the LTA wishes to implement the LCTOP projects listed below.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Local Transportation Authority that the LTA hereby agrees to comply with all conditions and requirements set forth in the applicable statutes, regulations and guidelines for all LCTOP funded transit projects.

BE IT FURTHER RESOLVED by the Board of Directors of the Local Transportation Authority that it hereby authorizes the submittal of the following project nomination and allocation requests to the Department in FY 2018-2019 for LCTOP funds:

Project 1 Name: Expansion of Intercounty Services

- Amount of LCTOP funds requested: \$81,303
- Short Description of project: San Benito LTA will continue a 7am roundtrip to Gavilan College, which began using FY 2014-15 LCTOP funds, continue a 3:30pm roundtrip to the Gilroy Caltrain Station, which began using FY 2015-16 LCTOP funds, and will continue a 7:35am roundtrip to Gavilan College when the school is on break, which began using FY 2017-18 LCTOP funds.
- Benefit to Priority Populations: Project provides improved transit or passenger rail service
 for stations or stops within a disadvantaged or low-income community (e.g., new transit
 lines, more frequent service, greater capacity on existing lines that are nearing capacity,
 improved reliability, improved accessibility, bus rapid transit service).

Project 2 Name: Token Transit Agency Fees

- Amount of LCTOP funds requested: \$ 1,500
- Short Description of project: San Benito LTA implemented the Token Transit mobile fare payment app in August 2018. Token Transit charges LTA 10% of the final transaction value for each fare purchased over \$2.00. For all transactions less than \$2.00, the fee is \$.06 + 7%. This funding will cover the fees charged to LTA for Fiscal Year 2019-20.
- Benefit to Priority Populations: Project improves transit connectivity for residents at stations or stops in a disadvantaged or low-income community (e.g., network/fare integration, fare-system investments).

Project 3 Name: Free Fixed Route and Intercounty Service Days

- Amount of LCTOP funds requested: \$24,812
- Short Description of project: San Benito LTA will offer free Fixed Route and Intercounty service days during FY 2019-20.
- Benefit to Priority Populations: Project provides transit incentives to residents of a disadvantaged or low-income community or a low-income household (e.g.; transit vouchers, reduced transit fares, transit passes).
