#### **INFORMATION ITEMS:**

13. RECIEVE Monthly Caltrans District 5 Construction Projects Report – Brandy Rider, Caltrans

Caltrans Deputy District Director for Transportation Planning, Brandy Rider, provided an update on major construction projects on the Caltrans State Highway System in San Benito County and answered questions from the Board.

Director Sotelo inquired about the Hwy 156 project, stating these were questions that came up at the Board of Supervisors meeting. She asked about the status on what still needs to be done to prohibit left hand turns on Hwy 156. She also asked what the level of condition (traffic index, type of pavement levels) expected once the Hwy 156 project is completed, and the frontage road is turned over to the County. Lastly, she asked the status on last month's request for maps of Hwy 156 in its entirety.

Ms. Rider stated that Caltrans is working on an appropriate type of signage package to be installed, anticipated to be done in the next several weeks. Caltrans will provide an update when it gets closer to being installed. Regarding the frontage road, Caltrans plans to give the road back to the County in a state of good repair. Caltrans offered to meet with the County to provide more detailed information and mapping. Lastly, regarding last month's request for maps of Hwy 156, Caltrans is working on two different sets of mapping 1) mapping of the entire corridor, expected to be completed in the next couple of weeks. 2) mapping of the detour, expected to take a couple of months because they are still working those details out with construction.

Regarding prohibiting left hand turns on Hwy 156, Chair Freels requested that the word gets out on social media as soon as possible.

Caltrans will work with staff to get announcements out to the public. Caltrans also encouraged that the County reach out to CHP advising them about the resolution that passed, so they can be prepared for enforcement.

**14.** Caltrans Report/Correspondence – Brandy Rider, Caltrans

Caltrans Deputy District Director for Transportation Planning, Brandy Rider, announced that the California State Transportation Agencies have announced an open call for applicants to serve on the Interagency Equity Advisory Committee. It is a fifteen member committee that advises agencies on how to achieve meaningful outcomes and transportation equity. Committee applications are open until February 4.

There was no public comment.

**15.** Executive Director's Report – Abraham

Executive Director Abraham announced that Transportation Planning Manager, Veronica Lezama's last day with COG is January 24, 2024. She expressed how much COG appreciates all the work she has done over the last 20 years and wished her the best in her future endeavors. She was also pleased to announce the addition of two Transportation Planners to the COG team, Douglas Kean, and Samuel Borick. Ms. Abraham mentioned that she is working with SBC Water District on their plans to bring water pipeline to San Juan Bautista via the Hwy 156 frontage road. Ms. Abraham announced that staff submitted the Transit and Intercity Rail Capital Program (TIRCP) and Zero Emission Transit Capital Program (ZETCP) application on December 20th. She expressed appreciation to Administrative Services Specialist, Norma Aceves and Steve VanDenburgh, Consultant with Cathedral Oaks, for all of their work. Lastly, Ms. Abraham announced that COG's Highway 25 Workshop is scheduled for January 31, 2024. Staff will also be reaching out to the COG Board to schedule the COG Board Retreat and Strategic Planning meeting.

There was no public comment.

#### 16. Board of Directors' Reports -

Director Curro stated that she was excited about being on COG and looked forward to working and building that partnership with everyone.

Vice Chair Casey stated that COG got a lot of work done last year and she recommended working with the Executive Director to prepare a public announcement regarding COG's 2023 accomplishments that can be shared with the community through social media.

Chair Freels inquired about the maintenance of the bus stop shelters. He noted that the bus stop shelter on Fourth and San Benito Street needed to be cleaned.

Executive Director Abraham stated that MV Transit and COG staff have been maintaining the bus stop shelters. She noted that staff is aware of the issue and is looking into it.

Director Morales expressed appreciation to Veronica Lezama, not just for all of the work she has done for COG over the years, but for the community as well.

#### Recommendation:

Receive update on the purpose and development of the Metropolitan and Regional Transportation Plan (MTP/RTP)

#### Summary:

This staff report provides the COG Board with information regarding the contents, purpose, and development of the Metropolitan and Regional Transportation Plans.

#### Background/ Discussion:

The Council of San Benito County Governments (SBCOG) develops a comprehensive Regional Transportation Plan (RTP) every four years with the intention of addressing the current and future transportation needs of the entire county. The RTP is designed to guide transportation planning priorities over a minimum of 25-year period. The plan considers a variety of factors, including projected regional growth, input from the public, projected funding estimates, and directives from the COG Board of Directors. The final adopted RTP is a supporting document that is developed in close coordination with the Metropolitan Transportation Plan (MTP) which is created by the Association of Monterey Bay Area Governments (AMBAG). The MTP developed by AMBAG is broader in scope and it addresses the context and future needs of transportation systems across Santa Cruz, Monterey, and San Benito counties.

#### Features of the RTP

- 1. The RTP offers crucial context regarding the region's geographic setting, economic composition, and long-term demographic trends. This context shapes the general development of the plan and influences the selection of projects supported therewithin. By articulating goals that reflect the core values of both the county and state, the RTP establishes a guiding framework for future decision-making processes.
- 2. The RTP offers practical insights into the current and projected travel patterns and regional dynamics of San Benito County. This contextual information is essential for understanding the underlying issues and concerns that influence the transportation

projects included in the RTP. Additionally, the RTP analyzes the county's existing transportation infrastructure, emphasizing the alignment of regional priorities with anticipated future growth.

3. The RTP offers a comprehensive insight into the financial dimensions of transportation projects across the county. By outlining projected revenues and funding sources for the next 25 years, the RTP aims to prioritize projects in an effective manner. This ensures that the identified projects are supported with available funding, facilitating tangible improvements to our transportation infrastructure.

Towards Completion: Current Work and Next Phases

The current MTP and RTP, adopted in 2022, provide forecasts and planning initiatives until 2045. The new update of MTP and RTP, scheduled for adoption in 2026, provides planning staff with an opportunity to address the changing needs and priorities of the community and reassess the assumptions that guide our analysis. The horizon year for the new update will be 2050.

Currently, AMBAG and its regional partners are soliciting public feedback on the Notice of Preparation for the Environmental Impact Report (EIR). The EIR will assess potential environmental effects resulting from the planning process. The public comment period opened on January 26th, 2024, and closes on March 1st, 2024. Opportunities exist for written submissions regarding the EIR scope, and public workshops hosted by AMBAG, in coordination with SBCOG, are scheduled for February 21st and 22nd. The resulting EIR will serve as the EIR for both the MTP and RTP. The incorporation of these public engagement activities ensures the plan reflects the diverse perspectives and needs of the community.

In the coming months SBCOG will shift its focus to coordinate with AMBAG in the development of the regional growth forecast models. These forecasts will summarize population, job, and housing trends both across the entire Monterey Bay area and in county specific contexts.

COG staff will work in partnership with AMBAG to ensure modeling efforts reflect the goals and vision of San Benito as these forecasts are influential in determining how planning and funding opportunities are approached in the future. COG staff is actively in collaboration with AMBAG on this matter.

The San Benito County RTP serves as a crucial tool for shaping a resilient and responsive transportation system that meets the future needs of the community while preserving the region's unique rural character.

#### Recommendation:

Receive outlined priorities for transit in 2024.

#### Summary:

COG aims to boost post-pandemic ridership for LTA by analyzing causes, improving timeliness, frequency, alignment with land use, and enhancing transit facilities based on best practices and community input.

#### Background/ Discussion:

The COG is responsible for authorizing funding to the LTA and ensures that public participation processes and needs assessments are conducted. LTA services have seen a decrease in ridership since the pandemic. As of now, ridership has not bounced back to pre-COVID levels, which is the case at both a state and national level. Staff would like to investigate the causes of this ridership deficit and identify strategies to remedy it.

Staff deem it necessary to understand who isn't riding our service, why they're not riding it, and how that can be changed to make transit an attractive mode of travel for the community. Staff have identified three key areas to focus on.

- 1. Measuring productivity of transit services Timeliness, predictability, and frequency
  - a. Measuring effectiveness of service improvements through enhanced data collection and performance measures.
  - b. Analyzing current scheduling practices and their effect on service predictability and ease of use for riders.
  - c. Assessing the frequency of current services offered and determining if and where additional services should be added.
- 2. Alignment of land use patterns and transit operations
  - a. Develop transit routes around high-density residential and commercial centers.

- b. Greater coordination between SBCOG, City of Hollister, the County of San Benito, and City of San Juan Bautista to examine alignment between transit operations and land use patterns.
- 3. Promoting Transit Awareness Transit facilities, bicycle facilities, and pedestrian improvements.
  - a. New signage, bus shelters, and other amenities to increase the visual presence and importance of transit.
  - b. The addition of pedestrian and bicycle improvements within the vicinity of transit stops to improve safety for riders and the community at large.
  - c. The creation of mobility hubs surrounded by enhanced walking and biking facilities.

Staff would like to explore these factors that might boost transit ridership and develop strategies based on those very factors, paired with our rider feedback to make our transit more equitable, convenient, reliable, and accessible for the community as a whole.
