#### 5. MEMBER ANNOUNCEMENTS:

Jill Leal-Andrade announced that Caltrans Districts 4 and 5 will host a community engagement meeting on the SR 25 Safety Improvement Projects on September 3, 2025, from 5:00 p.m. to 7:00 p.m. at Paine's Restaurant. Additionally, regarding Rocks Road and US 101, Director Kosmicki raised concerns about having the median open. In response, Caltrans and County staff held a meeting to evaluate closing the median. After coordinating with Public Safety, it was decided that only emergency vehicles will maintain full access to the median opening. The project will start in early September.

Myranda Arreola provided an update on the Regional Traffic Impact Mitigation Fee (TIMF) Nexus Study. The Memorandum of Understanding (MOU) has been finalized and shared with all three jurisdictions for approval by their respective board and councils. Once approved, staff will present the MOU, along with the finalized scope of work and Request for Proposals to the SBCOG Board for approval later this month.

Samuel Borick provided an update on the development of the 2050 Regional Transportation Plan (RTP). Current efforts are focused on developing a draft 2050 RTP Budget and updating the draft EIR chapters of the 2050 RTP. Over the coming months, draft RTP chapters will be presented to the TAC for review and members are encouraged to provide feedback to ensure compatibility with local initiatives and policies.

Heather Adamson reported that AMBAG is working closely with SBCOG, Monterey, and Santa Cruz RTPAs to finalize budget details in preparation for releasing the draft RTP for public comment. The draft RTP is scheduled to be released in Fall 2025, with final adoption of the 2050 RTP scheduled for June 2026.

Subject: 2050 Regional Transportation Plan Meeting Date: October 2, 2025

Update

#### Recommendation:

RECEIVE update on the status and development of the 2050 Regional Transportation Plan.

#### Summary:

The Council of San Benito County Governments (SBCOG) is currently in the process of updating the 2050 Regional Transportation Plan (2050 RTP). Recent efforts are focused on developing a draft 2050 RTP Budget, drafting chapters of the 2050 RTP, and assisting in the development of the programmatic environmental impact report (EIR). To ensure the 2050 RTP accurately reflects the transportation policy and investment priorities of the San Benito region, SBCOG is collaborating closely with the Technical Advisory Committee (TAC) throughout the update process. The final 2050 RTP and EIR is scheduled for adoption in June 2026.

#### Background/ Discussion:

The RTP is a 25-year planning document that guides the development and maintenance of the region's transportation system. Updated every four years as required by law, the RTP focuses on transportation policy and investment priorities. An overall goal of improving the quality of life for residents is pursued through transportation accessibility and mobility investments that also enhance economic and environmental conditions throughout the county. During this process, SBCOG relies on ongoing collaborations with the TAC to ensure the 2050 RTP aligns with local initiatives and policies. RTP items are routinely brought to the TAC for review and comment before being presented to the SBCOG Board.

For adoption, the 2050 RTP must be supported by a programmatic EIR. A programmatic EIR evaluates the overall environmental impacts of broad, long-range plans, such as the RTP. Projects included in the RTP project list are not covered by the programmatic EIR and must still obtain necessary environmental clearances before implementation. The Association of Monterey Bay Area Governments (AMBAG) is the lead agency in preparing the programmatic EIR. This EIR will serve as the EIR for AMBAG's 2050 Metropolitan Transportation Plan (MTP) as well as for the RTPs of the Regional Transportation Planning Agencies (RTPAs) in the Monterey region, including the Transportation Agency for Monterey County (TAMC), the Santa Cruz County Regional

Transportation Commission (SCCRTC), and SBCOG. AMBAG and the RTPAs coordinate on the EIR to ensure consistency in environmental review across plans. The draft EIR is scheduled to be released for public comment in late 2025.

At the August 2025 TAC meeting, staff presented committee members with an overview of the 2050 RTP budget elements and provided an update on its status. Based on the input received from local member agencies and the Association of Monterey Bay Area Governments (AMBAG), SBCOG is now bringing forward a balanced draft RTP budget for review and discussion.

To achieve a balanced budget, staff reviewed all revenues and expenditures in the plan, working to identify and address funding gaps and surpluses. This process included evaluating specific revenue and expenditure categories for alignment, assessing the timing of planned expenditures, and ensuring that sufficient revenues would be available when needed. Attached to this staff report is the draft 2050 RTP budget (Attachment 1). The draft 2050 budget reflects the financial constraint of more than 160 transportation investments totaling roughly \$1.9 billion.

In addition to developing the 2050 RTP Budget, SBCOG is working to update the chapters of the RTP. Draft chapters will be circulated to the TAC for review and comment over the coming months, prior to consideration by the SBCOG Board for adoption. Input from TAC members helps ensure the RTP is consistent with local initiatives and aligned with adopted policies.


